Conditions of Entry

- 1. By entering this **Promotion**, Entrants agree to abide by these Conditions of Entry.
- 2. The **Promoter** is Police Financial Services Ltd ABN 33 087 651 661 AFSL 240293 trading as BankVic (**BankVic**) of Level 3, 215 Spring Street, Melbourne, Victoria 3000.
- 3. The Promotion commences at 9am AEST on 1 May 2022 and closes at 5pm AEST on 31 May 2022 (Promotion Period).
- 4. An **Entrant** is anyone who is a resident of Victoria and aged 18 years or over who successfully completes an Entry.
- 5. Employees and directors and their immediate families (spouse/partner, child or parent), of BankVic, Hawthorn Football Club and agencies associated with this Promotion are ineligible to be Entrants.
